MEETING MINUTES - November 21, 2012

INTRODUCTIONS

President Chuck Roberts called the meeting to order at 7:35 PM in Lincoln, NE.

APPROVAL OF MINUTES

Minutes from the October meeting were approved after correction to delete reference to Kerry Fox, who was not in attendance at that meeting.

TREASURER'S REPORT

The Treasurer's report was given by Gerry Tice. A motion was made to accept the report and seconded. Motion passed. Bills were presented by Jim Snyder in the amount of \$178.06 for expenses related to the 2013 swap meet, and Secretary Alan Tast in the amount of \$171.06 for printing and mailing of the November minutes; a motion by Kerry Fox and seconded by Chuck Garber for payment was approved.

OLD BUSINESS

SWAP MEET

Job Assignments: Swap Meet Co-Chair Tom Green asked that people representing their clubs sit down with him after the meeting to discuss job assignments.

Pre-Event Training Session: Tom repeated the question asked at the October meeting, asking if there was any value in continuing training sessions on the Sunday before the Swap Meet (a.k.a. Super Bowl Sunday). Following lengthy discussion, a vote was taken to discontinue the training session.

2013 COUNCIL DUES COLLECTION CONTINUES THROUGH DECEMBER

Treasurer Gerry Tice noted that 2013 ENWICC dues collection had begun in October, and that dues are payable at this meeting and at the December Omaha meeting. In order to be listed in the 2013 Calendar of Events book, dues need to be submitted no later than December 31st, 2012.

Secretary Alan Tast sent a mailer prior to the October meeting to listed representatives of those clubs which did not submit dues for 2012 to remind them that unless dues are paid by the end of December 2012 they will not be listed in the 2013 Calendar of Events book. Several clubs have responded by providing their dues for 2013.

CLUB/REPRESNTATIVE LIST UPDATES

Secretary Tast passed around a list of clubs and representatives, asking for updates to listings. Alan asked clubs to add information related to national/international clubs that can be listed in the 2013 Calendar of Events. Clubs also need to inform Alan as to the two names and contact information that they wish to have listed both in the Calendar and on-line – a reminder along with a preliminary contact list will be provided with the December newsletter to facilitate this effort.

2013 CALENDAR OF EVENTS BOOK

Secretary Tast reported on the meeting he had with Paul Swanson of Suburban Newspapers, Tom Knox of the Omaha World-Herald, and Valerie Cutshall on November 14th to discuss production of the 2013 Calendar of Events book. Paul has agreed to attend the December meeting to discuss advertising sales/rates, answer questions, and provide an update on event submittals, which are being managed in part by Tom. Valerie, who is working for Suburban Newspapers in a freelance capacity, has been making initial and follow-up contacts with entities listed in the 2012 book to confirm listings for 2013. For 2013 the entire book will be placed online, including advertising: a link to the website that the book will be hosted on is to be provided to the Council's webmaster. Same as for 2012, a total press run of 9000 copies is planned on glossy paper, with 32 pages of color ads. Alan passed on to the production team comments that had been voiced by long-time Calendar advertisers regarding availability of books for distribution. Paul noted that delivery of books prior to the Swap Meet will be coordinated with Boyd Ready.

In response to Vice President Murabito's questions about ad space for the 2014 Swap Meet and the Foliage Tour, Paul commented to Alan that space had been set aside in the center of the 2012 book for the Swap Meet ad, along with another full-page layout dedicated to the Council's history, but that additional space for the Fall Foliage Tour was limited to space left over at bottoms of pages filled with paying ads. For the 2013 book, an attempt can be made to reserve space for a half- or full-page ad for the Foliage Tour, provided that ad copy can be provided before the end of December. Some suggested at the October meeting that the Council try to get the back center pages for both ads. An updated club list, Council history and mission statement for the 2013 book is to be provided to the publisher after the end of December. Alan also voiced a desire to be able to proof pages with Council-provided content prior to final publication. Jim Snyder commented that he had only heard good comments about the book since Suburban Newspapers had become involved with its production.

Those groups wishing to have their events listed in the Car Council's 2013 Calendar of Events and purchasing display advertising are reminded to begin compiling their information for submittal – deadline for event listings submittal is January 11, 2013, while display advertising deadlines may differ.

NEW BUSINESS

GOLDEN CORRAL MEETING POLICY FOR USE OF ROOM REMINDER

Prior to the meeting, the manager of the Golden Corral brought to the attention of Vice President Roy Murabito that his staff have reported instances of meeting attendees not paying for food taken from the buffet lines. We are allowed to use the meeting room for free *provided that meeting attendees purchase meals*. If there are future instances of people not paying for meals or other items consumed (coffee, pop, etc.), we run the risk of losing our present Lincoln meeting location. Please do not abuse or jeopardize our current arrangement with Golden Corral.

COUNCIL BY-LAWS - ONLINE ACCESS AND CURRENT EDITION AVAILABILITY

Secretary Tast asked if a more-current copy of the Council's By-Laws was available for distribution to clubs which have recently joined the Council. A copy of the original By-Laws that was provided by Roy Murabito did not reflect the current club dues policy, which was amended prior to 2006 to update this, according to former Secretary Jim Snyder. Alan also wanted to make available the most-current copy via the Council's website so that Council members could have it available on-line for their use. Following intense discussion, a motion was made by Jim Snyder and seconded by Leonard Bouc to not place a copy of the By-Laws on the Council's website for distribution to member and non-member organizations; a follow-up motion was then made by Roy, seconded by Ray Moyer and approved by those present to have the Council's Board of Directors, which is comprised of past presidents, review the current By-Laws prior to the April meeting and provide their recommendation for potential revisions if needed.

(Following the meeting, Jim Snyder forwarded to Secretary Tast a copy of the most-current revision of the By-Laws, which was made in 2004 and does include the current dues policy. Those wishing a copy of this are asked to contact the Secretary to obtain one.)

RETIREMENT OF COUNCIL TREASURER - REPLACEMENT NEEDED

Treasurer Gerry Tice has indicated that the time has come for him to step down as the Council's treasurer. Gerry, who has held the position since 1984, has severed selflessly in this capacity and for this the Council is eternally grateful. Nominations for Gerry's replacement will be taken as part of the officer nomination process for 2013-2014, which begins at the January meeting and concludes with a vote to be taken at the March meeting, for all executive positions (President, Vice-President, Secretary and Treasurer).

2013 COUNCIL SCHOLARSHIP APPLICATIONS

Vice President Murabito reminded all that it was time to begin work on mailings to area high schools and their guidance counselors for the Council's annual scholarship program. The Council in the past has provided scholarships of up to \$500 for graduating high school seniors seeking to continue their education in automotive technology at trade schools, community colleges or universities. Jim Snyder made a motion that was seconded by Ray Moyers to continue the scholarship solicitation – the motion was passed. Jim also announced that Ken Lamb from the Midwest Street Rod Association of Omaha, has asked for the Council to provide a presentation on the scholarship program during Career Day at the annual World of Wheels show at the end of March.
