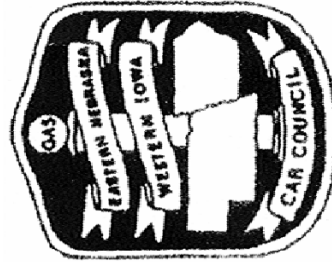
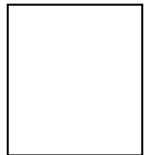

MEETING MINUTES - November 18, 2013

INTRODUCTIONS

President Chuck Roberts called the meeting to order at 7:40 PM in Lincoln, NE.

APPROVAL OF MINUTES

Boyd Ready motioned, with a second Jim Snyder, to approve the October minutes after a correction to revise the dollar amount raised by the Slo Rollers from \$17,000 to \$1700. Motion passed.

TREASURER’S REPORT

The Treasurer’s report was given by Boyd Ready and accepted after a motion made by Jim Snyder and seconded by Ray Moyer to approve. Bills were presented by Secretary Alan Tast for \$100.86 for printing and mailing of the November newsletter; a motion was made by DJ Hogan and seconded by Leonard Bouc to pay the bills. Motion passed.

OLD BUSINESS

2014 ROCKY MANGINELLI SWAP MEET

Jobs: Kerry Fox announced that most jobs had been confirmed by previous holders. Those clubs wanting to review their previous job assignments and verify if they want to drop, keep or change jobs must contact Kerry by calling 402-499-9711 or email kfox@inebraska.com.

Equipment Needs: Boyd Ready brought up some equipment items that need to be taken care of. Two-way radios were down to five serviceable units, with a need for an additional six to eight. More flashlights and safety vests are also needed to replace those which were not returned at the end of previous swap meets. No motion was needed for replacing these items as the cost of these are part of the normal operating expenses incurred for the meet and paid for from the swap meet account.

Food Bank Milestone: Roger Neeman reminded all that monetary and food donations anticipated for the 2014 Swap Meet should push the overall totals over \$100,000/100,000-pounds since the

program began 21 years ago. In order to promote these milestones, Roger asked for ideas on how to acknowledge this during the meet. Chuck Garber recommended that local media be informed of this in order to get news coverage, while Kerry suggested that signs should be made for display on the grounds and at the gates pointing out amounts donated to date with a "Thank You" to those who have donated. Alan added that the Council can play up the goal of breaking \$100,000/100,000 pounds by publicizing it in the Council newsletter, on the Council website, in the Calendar of Events book and by issuing press releases in conjunction with the Food Bank of Lincoln.

Swap Meet Rates: Jim Snyder noted that rates for 2015 spaces will be the same as for 2014. There will be a need to review rates for 2016 and beyond as our current commitments with the Lancaster Event Center are set for 2014, 2015 and 2016.

2014 CALENDAR OF EVENTS BOOKS

Alan met with Paul Swanson of Suburban Newspapers prior to the September meeting to confirm change book size and begin the process for setting up the 2014 Calendar of Events Book. Swanson is expecting that with the change in format size to 6" x10 1/2" and savings in printing costs that a total of 10,000 books will be printed for 2014. All pages will have the capability for color. It is anticipated that black-and-white ad rates may hold while color ad rates may increase.

On-Line Version: Secretary Tast reminded all that the entire 2014 book will be placed online, including advertising, as had been done for 2013. To access the Directory/Calendar, people will need to go the Council's website at www.enwicc.com and click on the photo of the cover page of the Directory.

Individual Copies/Availability: Those who still wish a hard copy of the book need to be told that, the Council has exhausted its supply of books for the year. People will need to go to the Council's website, from which they can print event and club listings.

Event Submittal Deadline January 14, 2014: Alan reminded all that event listings need to be submitted no later than January 14, 2014: a form will be included in the December newsletter (this can also be found in the front of the 2013 Calendar of Events book).

Club/Representative Updates for Calendar: All clubs need to provide Alan with updated listings for representatives and contact information at the December meeting, or contact Alan with this information prior to December 31st.

CHRISTMAS 2013 CHARITABLE DONATIONS

Suggestions from the floor were taken for this year's donations. Donations were made in 2012 to four charities on behalf of the Council in the amount of \$250/each to the following:

- Tangier Shrine Transportation Fund - Omaha
- Matt Talbot Community Kitchen & Outreach Center – Lincoln
- Sienna Francis House – Omaha
- Camp Quality Northwest Missouri– St. Joseph, Missouri

Tom Kneebis asked that for 2013 the Northwest Missouri Advocacy Center be the recipient in place of Camp Quality in order to spread donations around to different groups that would benefit. Roy Murabito made a motion to carry over donations in the amount of \$250/recipient to the Tangier Shrine Transportation Fund, Matt Talbot Community Kitchen & Outreach Center, and the Sienna Francis House and Northwest Missouri Advocacy Center; with a second from the floor, the motion was passed unanimously.

NEW BUSINESS

2014 COUNCIL DUES NOW PAYABLE

Roy Murabito reminded all that 2014 Car Council dues have been payable as of October 1st and will be delinquent as of December 31st. Please remind your clubs that dues are 25 cents/member (minimum \$10/club) for the year. Checks may be made out to ENWICC-2014 Dues and either brought to the October-November-December meetings or mailed to the Treasurer (see inside of cover page for mailing address).

2014 PAUL HIGH MEMORIAL SCHOLARSHIPS

Roy Murabito announced that the Scholarship Committee has begun preparing mailings to high schools in the region with applications for the Paul High Memorial Scholarship program. Mailings traditionally are made during December. Boyd Ready made a motion to continue the Scholarship program and send out the applications in December; motion was seconded by Chuck Garber and passed unanimously.

LANCASTER EVENT CENTER CHANGES MAY IMPACT SWAP MEET

Changes at the Lancaster Event Center may impact future swap meet space availability. Alan and Boyd both recapped stories that appeared in the Lincoln Journal-Star regarding the retirement of manager Ron Snover at the end of December. The articles pointed out that the Lancaster County 4-H clubs have been pressuring the County Board to provide spaces for their activities at the same time that other events are being held, citing one instance earlier this year when a 4-H event was cancelled at the last minute for another paying event. Kerry and Boyd also noted that plans are moving forward for a new building and parking areas, and that these improvements may impact the Council's access to the grounds. Boyd also brought up that there may be some confusion regarding contract language for the first Sunday in March: at present we are confirmed for dates for the next three years, but there may be problems moving beyond 2016 that will require confirmation. Kerry and Boyd will meet with Event Center staff prior to the December meeting and report on the results of their discussion.

PAST EVENTS

LAMBRECHT CHEVROLET DEALERSHIP AUCTION UPDATE

A story in the Omaha World-Herald reported that 17 bidders had backed out on bids made on cars that had been auctioned at the September 29th event in Pierce, Nebraska, and that affected cars are being placed back up for sale. Among the cars placed back on the auction block, which is being conducted on-line, a "new" 1963 Corvair with 0.1 miles that had been bid up to \$10,000.

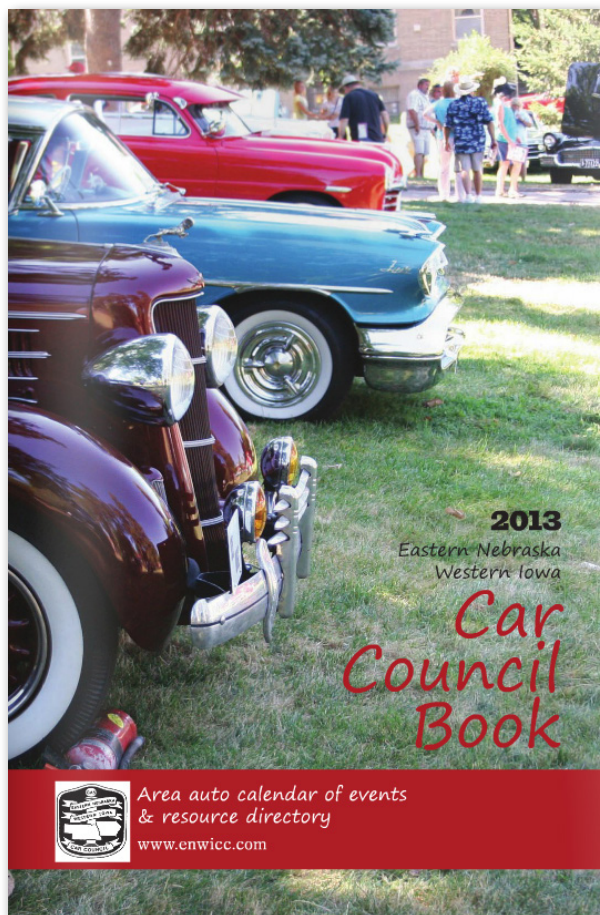
