MEETING MINUTES - July 15, 2015

INTRODUCTIONS

APPROVAL OF MINUTES

Kerry Fox made a motion to approve the minutes of the June meeting. Motion seconded by Marvin Cooper. Motion carried.

TREASURER'S REPORT

Treasurer Boyd Ready read the Treasurer's report. Motion to approve Treasurer's report by Marvin Cooper. Seconded by Jim Snyder. Motion carried. Three bills were submitted for payment. Scholarship Fund expenses of \$20.65 to Jim Snyder, newsletter expenses of \$71.31 to Cindy Wimmer and a bill to be paid to the U.S. Post Office for \$66.00. Ray Moyer made a motion to approve the bills as presented. Seconded by Kerry Fox. Motion carried.

SWAP MEET

Kerry Fox talked about helping collect for parking at the Lancaster County Fair which will be held this year from July 30 - August 9. We would need to get online to look up the exact times and dates. They are wanting us to do 6 hour shifts for collecting. We should be doing this for the experience we will gain for collecting for the Lincoln Swap Meet this coming spring. Kerry was going to check on the availability to work shorter time frames. He also reported that the perimeter fence is almost done. It is a three rail white wooden fence which will keep people from driving thru it and will help to enforce paying for parking. As for the swap meet, we will be looking at using our traffic control people for parking collections next year. In the next several months, we will be addressing this issue.

INSURANCE

Boyd said that Farm Bureau will be contacting Ron Gillis when Ron returns from his vacation. Kerry Fox told Farm Bureau that we are a non-profit organization and that a lot of our car club members have their own insurance and that we do not need to insure the car club members. Kerry and Ron Gillis have tried to educate Farm Bureau about our organization. The same insurance agent that insures the Lancaster County Event Center said that his rough estimate of what our insurance should cost was somewhere between \$2,500 to \$4,000 a year. Not many insurance companies will insure an event as large as our annual Swap Meet. Ed Packard of K & K Insurance may be able to insure us.
